Applications are invited for admission into the following UG courses of KBR College of Agriculture affiliated to Acharya N.G. Ranga Agricultural University (ANGRAU), Guntur, Andhra Pradesh under Management quota (15% supernumerary) for the academic year 2024-25.

Number of seats are interconvertible among degree courses based on the demand Academic Eligibility:

Degree	Eligibility
B.Sc. (Hons) Agriculture	Two years intermediate course of 10+2 level or 12 years schooling or its equivalent examination in Physics, Chemistry, Biology subjects and English. Appeared for EAPCET / Diploma holders Appeared for AGRICET.

- Students admitted under these quota are governed by ANGRAU undergraduate Academic guidelines.

Age: The candidates for admission to this course in the University shall be required to have completed 17 years of age on the 31st of December, 2024 of the year of admission with an upper age limit of 22 years for all the candidates.

General Eligibility Norms for seats under Management

Management Category:

The candidates who are claiming under Management quota shall satisfying the following:

- I. Applicant shall be the ward of Indian citizen by him / herself.
- II. The Management parent shall be
 - a. Shall have the annual income sufficient to support the course of study of his/her ward.

Criteria for selection under Management quota

- The eligible candidates applied under Management quota shall be selected based on merit in the prescribed subjects of in Intermediate / 12th class examination/ or its equivalent.
- In case of other equivalent examinations passed by the candidates, the weightage of marks obtained in the prescribed subjects shall be reckoned on a par with those of the two year Intermediate examination.
- Based on the rank obtained in AP EAPCET / AGRICET

Undertaking by the parent & candidate, if applied under Management:

- The candidate and parent is required to give an undertaking in the format appended as **Annexure-I** on Non-Judicial stamp paper worth Rs. 200/- or (Rs.100/- + 100/-) duly Notarized.

Fee Structure For Mangement quota

- **Tuition fee:** As per the Guidelines given by Higher Education and Government of Andhra Pradesh
- **Hostel Fee:** Establishment fee and mess fee will be applicable as per the convener quota students
